The EOB Inc annual shareholder meeting will be held on Saturday, August 28, 2010, beginning at 10:00am. The meeting will be held at the Spirit Lake Library community room. Please enter using the northwest door and not the main library entrance.

The agenda includes financial report, election of board members, and a report on the road and drainage project. The terms of Arnie McIntosh and Dwight Jacobs are up for election. Both Arnie and Dwight have stated that they would like to continue serving on the board. The project report will include current status of the work being done, an explanation of the various LID practices, information on run-off water quality improvements, signage of the LID practices, as well as future monitoring.

A light lunch will be served at the conclusion of the meeting.

To vote at the meeting, you must be an EOB Inc shareholder. We will have the current list available at the meeting. You must be a property owner in EOB to purchase a share. You may purchase a share at any time, including the annual meeting. The share cost is \$25, one per property owner, share is non-transferable and non-refundable.

If you have not paid your 2010 EOB Association annual dues, please do so asap and save your association the cost of further invoices. If you have not received an invoice, please contact Jon Kruse. Your dues are the sole source of funding for your EOB association.

Road Project continues

Weather permitting, construction of the LID practices (rain gardens, bio-swales, etc.) is to start shortly after the 4th of July. This portion of the project will be completed in the fall. Your EOB association will be providing identification signs for each of the LID's. Presently, there are 151 LID's planned. As the project nears completion, the county will be evaluating traffic patterns, speed limits, stop sign locations, and other sign placement. They will determine what changes need to be made. The mail boxes will be returned to the yards of those who had them at the end of the project this fall. The scheduled completion of the total project is this fall.
